ADDITIONAL ARTICLES OF INCORPORATION

DB Baseball of Northern Colorado, Inc.

Purpose

The Corporation is organized exclusively for charitable and educational purposes, including for such purposes, fostering amateur sports competition and supporting and developing amateur athletes for that competition, and the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section(s) of any and all future federal tax code(s).

Disbursement

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions for league purchased items and for reimbursements to Board members and coaches for expenses incurred on behalf of the Corporation.

Political Activities

No part of the activities of the Corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation. The Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the Corporation shall not carry on (a) any other activities not permitted to be conducted by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or corresponding section of any and all future federal tax codes, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Indemnification

No member, officer, or director of this Corporation shall be personally liable for the debts or obligations of this Corporation of any nature whatsoever, nor shall any of the property of the members, officers, or directors be subject to the payment of the debts or obligations of this Corporation.

Each director in consideration for his services, shall, in the absence of fraud, be indemnified, whether then in office or not, for the reasonable cost and expenses incurred by him in connection with the defense of, or for advice concerning any claim asserted or

proceeding brought against him by reason of his being or having been a director, of the Corporation to the maximum extent permitted by law. The foregoing right of indemnification shall be inclusive of any other rights to which any director, may be entitled as a matter of law.

Purpose

DB Baseball of Northern Colorado is a new organization and we are excited to bring a new breed of youth baseball to Northern Colorado. Our program is youth amateur baseball for children ages 9 to 14 years. We believe our program is different. As an organization, our goals are twofold:

• The delopment of the baseball player to perform at the pinnacle of his/her abilities for the purpose of furthering the team first and the invividual last.

• The development of the individual: Life skills that will help the participant be successful in the present and later in life. These goals are decribed in our Mission Statement:
